ORDER

In exercise of the power conferred by clause (a) of sub-section (1) of section 9 of the Indian Stamp Act, 1899 (Central Act 2 of 1899) (hereinafter referred to as the "said Act") and in supersession of the Government Order partial modification of the above read Order No. 35/1/2002-RD(5902)/1849 dated 28/09/2018 published in the Official Gazette, Series II No. 27 dated 4/10/2018, the Government of Goa hereby remits the entire stamp duty chargeable on any instrument other than those mentioned in clause (a) of sub-section (2) of said section and falling within entry 96 in List 1 in the Seventh Schedule to the Constitution, when executed in any part of the State of Goa by or in favour of the Ex-Serviceman or his widow, in respect of one transaction only, either relating to purchase of a agriculture plot or a residential structure, for their personal benefit, subject to the condition that such ex-serviceman or his widow, as the case may be, furnishes an undertaking to that effect.

Note : The aforesaid remission of Stamp Duty shall not be allowed on instruments executed for any commercial, business or real estate activities.

The Order shall come into force on the date of its publication in the Official Gazette.

In exercise of the powers conferred by clause (a) of sub-section (1) of section 9 of the Indian Stamp Act, 1899 (Central Act 2 of 1899) (hereinafter referred to as the "said Act"), and in supersession of the Government Order No. 35/1/2002-RD(5902), dated 29/11/2002, published in the Official Gazette, Series II, No. 37 dated 12/12/2002, the Government of Goa hereby remits the entire stamp duty chargeable on any instrument other than those mentioned in clause (a) of sub-section (2) of said section and falling within entry 96 in List I in the Seventh Schedule to the Constitution, when executed in any part of the State of Goa by or in favour of Ex-Servicemen or their windows, in respect to two transactions only, relating to purchase of a agricultural plot and / or a residential structure for their personal benefit with immediate effect, subject to such ex-serviceman or his widow, ~~as~~ the case may be, furnishing an undertaking to this effect.

Note: the aforesaid remission of stamp duty shall not be allowed on instruments executed for any commercial, business or real estate activities.
